

Atherton and District Dressage and Equestrian Association (ATDDEA)

Rules for Use of New Arenas at Kerribee Park on non Club Days

1. Who may use the arenas?

Rider or Group

Only members of the ATTDEA who

- are members of EA (and therefore insured to ride anywhere) or
- have public liability and personal accident insurance that covers them to ride anywhere.

Rider under Instruction

In addition to the above, if the rider is under instruction, the instructor/coach:

- must be a member of the ATDDEA;
- must be qualified as an instructor/coach; and
- have public liability and personal accident insurance that covers them for and while instructing/coaching. The insurance documentation must be sighted by either the club president or club secretary and a copy given to the club secretary for the ATDDEA records.

ATDDEA members are defined as fully paid annual members or life members. If ATDDEA membership has not been paid and the liability waiver not signed the rider is not a member for that year.

Temporary ATDDEA membership of the club is available for \$25 giving membership for 1 event only per calendar year. Full membership can then be bought with a discount of \$10 in the same calendar year.

2. How to book the arenas?

Call or email either the club secretary or the club president and they will liaise with Kerribee Park management to check availability and surface suitability. The time will then be confirmed (or not!).

There are no other ways to book or use the arenas.

Those booking the arenas must provide evidence of insurance and/or instructing qualifications to the president or secretary of the ATDDEA.

Only ATDDEA members can use the arena.

3. Safety:

All riders must wear hat, gloves and footwear consistent with EA rules and regulations.

Riders must be aware of the club Risk Management Plan. A copy of which is displayed on the club website <http://atddea.webs.com/events>

Riders should be aware of hazards of using these unfenced arenas and note there are other horses in neighbouring fields.

Riders must walk and inspect the arenas and surrounds prior to use in order to satisfy themselves that the arenas are safe to use.

Use of the arenas is entirely at the rider's own risk and your club member's dangerous sports waiver covers this.

The rider must have an observer present with access to a mobile phone and vehicle in case of an emergency.

4. Cost:

Booking	Cost for one arena	Notes
Individual member	\$10	Max 2 hours
Group of members (2+)	\$10 per rider	Max 4 hours
Group of members (2+)	\$15 per rider	All day
Instructors/coaches	\$5 per rider per lesson	Minimum charge \$10

No more than 2 riders may be in an arena at any one time.

If overnight camping is required this is charged at normal Kerribee Park rates \$6 per night and payable to the ATDDEA.

Charges are payable on booking and are non-refundable.

Charges are subject to review by the ATDDEA committee and may be changed.

5. Venue, Poo removal and site cleaning:

We are invited guests at Kerribee Park. You must familiarise yourself with the ATDDEA conditions of entry form which covers venue rules prior to arriving at the venue. It is imperative that these rules are followed.

Any members or instructors identified as not following the venue rules will not be allowed to book the arenas again.

It is the responsibility of every user of the arenas, stalls and grounds to keep the grounds free of horse poo, hay and other rubbish. **ALL** rubbish must be taken home or put in the bins provided (including tea bags, baling twine etc.). For poo and hay there are 3 alternatives:

- a. Bag the poo and hay and dispose of it (i.e. empty the bag) on the pile behind the museum (the white building at the entrance)
- b. Bag the poo and hay and take it home
- c. At some club events there is a trailer provided for the disposal of poo and hay.

Any members or instructors identified as leaving poo, hay, debris and rubbish on the arenas, stalls and surrounds will not be allowed to book the arenas again; there will also be a name and shame on the website.
