

# Conditions of Entry

*Please read carefully. If you require clarification of the conditions, please ask the organising committee at or prior to the event.*

This event will be held in accordance with current EA National Dressage Rules effective 01 January 2026 and any subsequent amendments and ATDDEA rules and policies. The onus is on the competitor to know the rules. The conditions below are relevant for competitions held by ATDDEA.

The ATDDEA committee reserves the right to alter, amend or cancel any event on the program without notice.

All riders must be aware of the rules surrounding [Horse Welfare](#) and the role of Stewards and Marshalls at all ATDDEA events. [EA Dressage Rules](#) (Refer to section 4.4).

Riders must be aware of the recent EA rulings banning clipping/shaving or modifying sensory hairs (whiskers) or removing or shortening the hair within the rims of the auricle (ears).

### Entries:

Entries are via Nominate - <https://nominate.com.au/>

Scratching and refunds are managed via Nominate - <https://nominate.com.au/>

A refund may only be made if documented proof (i.e. veterinary or medical certificate) is received by the Secretary within 7 days of the day of the event. 30% of the nomination fee will be withheld for administration.

Should the event be cancelled for any reason beyond the club's control, any refund will be at the absolute discretion of the ATDDEA Committee and will be based upon the amount of irretrievable expenses for that event.

The Draw position/s cannot be changed without the permission of the ATDDEA Organising Committee.

Competitors in **Closed Restricted competitions** must be current ATDDEA Club members.

Competitors in **Official competitions** must hold a current Competitive EA membership. The club encourages all Official competitors to also become ATDDEA members to help support the club.

To be eligible for a Championship Event award/s, Closed Restricted competitors must have competed in one other ATDDEA competition that same year.

All riders must complete and hand in a Biosecurity Horse Health Declaration Form at first gear check at all ATDDEA events.

All riders are required to assist with various tasks at each event. If no preference is indicated then a task will be assigned by the organising committee.

EA Official Competitor riders must:

- provide EA registration number(s), bridle number(s) of horse(s), and EA rider membership number when nominating
- enter Official competitions at their correct graded level or above or ride HC in competitions at or below their level

It is the responsibility of the competitor to ensure the nominations are made correctly regarding the horses graded level at the time of entry close date.

HORS CONCOURS (HC). Riders wishing to ride HC must declare their intention in writing before the event.

**Entry Fees, per class:**

**Official: \$15**

**Closed Restricted: \$15**

**Juniors: \$10**

**\*EA/Non ATDDEA Club Members \$40**

**\*The EA/Non ATDDEA club member** fee of \$40 per class will only apply to EA riders within a 300km distance of Mareeba.

**Junior riders** competing in Open competitions are required to pay the Open entry fee.

**Competitions:**

**1. Competitions:**

- **Official Competitive** competitions: Open to all EA Competitive dressage members. Official competitions attract grading points.
- **Closed Restricted** competitions are open to ATDDEA club members.

**2. Horses/Ponies EA registration:**

- **Official Competitive** competitions are open to horses or ponies with EA full horse registration.
- **Closed Restricted events:** EA horse registration is not compulsory (but encouraged).

One rider per horse for the entire event. Refer to rule 4.2g

Where a competition is shown as an Open competition both junior and seniors riders are eligible to enter and may compete in junior and open competitions on the same horse.

Horses may only compete in 2 consecutive levels; Prep/Prelim, Prelim/Novice, Novice/Elem. etc.

Horse can enter and compete in no more than 3 tests in one day. This may include a Freestyle Test. FEI only two tests.

Test Calling is allowed unless otherwise specified.

From 24hrs prior to the event starting, a horse may be ridden only by its nominated rider on the competition grounds. Refer to 3.12.2d

For Official Competitive competitors bridle numbers (2) - one on either side of the horse, must be clearly displayed so that the judge can identify the rider when riding in front of the judges' vehicle. Official tests: Riders are not required to stop at the judge's car.

For Unofficial or club riders, Horse Numbers are issued by ATDDEA to each horse and you are required to wear these on either side of your saddle blanket. Riders are not required to stop at the judge's car.

Horses entered for Official Competitive competitions can compete in Closed Restricted Club competitions one level above Official level. (Only 2 consecutive levels per event).

Freestyle competitions (when offered) are open to Junior and Senior riders and are graded Novice to Advanced as per EA 2023 Dressage Tests. Preliminary club tests may be offered.

Pony Dressage and Amateur Rider entrants will be grouped together either at the beginning or the end of a competition and may receive separate Pony results and ribbons.

Stallions will only be accepted on the grounds under the current EA Stallion Safe Practice Guidelines for identification and must always wear the EA stallion identification – see guidelines on the EQ website. <https://www.equestrian.org.au/news/health-safety-and-welfare-update-november-2025>

Etiquette for the competition & warm-up arenas shall be observed at all times as per Section 3 of the [EA Dressage Rules](#)

Random swabbing may take place at any event. A reminder for all competitors to always have their horse's EA registration papers with them at EA events. If approached by an Official Steward/Vet Officer of the day, the competitor, or the person responsible for the horse must allow samples to be taken from their horse for drug testing.

Prize money and ribbons will be awarded at Presentation after the scoring is completed either on each day or the last day of the competition.

Prize money, see below, is awarded at all competitions and is the same for all competitions throughout the year, including the Championships.

- Official: \$25, \$20, \$15
- Closed Restricted: \$20, \$15, \$10
- Junior: \$10, \$8, \$5

#### **Junior Categories:-**

- **Age group category: 12 and Under Competitions:** riders must be 12 years of age or under as at 1st January of the current year.
- **Junior competitions:** riders must be 16 years and under as at 1<sup>st</sup> January of the current year.
- **Senior classes:** riders must be 17 years and over as at 1<sup>st</sup> January of the current year.
- **Open Classes:** All age groups

#### **Youth Competitions**

- Youth Rider competitions will be offered at ATDDEA Championships for Closed Restricted riders. Riders must be under 20 years & under as at 1<sup>st</sup> January of the current year.

**Junior riders** competing in Open competitions are required to pay the Open entry fee.

#### **Dress, Saddlery & Equipment**

It is the competitor's responsibility to ensure all dress, saddlery and equipment complies with [EA Dressage Rules](#) (Refer to section 5).

Competitors must wear long, short or sleeveless shirts (ratcatcher or collared). Stock to be worn with a ratcatcher and tie with collared shirt.

#### **Gear Check**

All Closed Restricted competitors are required to present for a gear check to a Steward or a Marshall prior to and immediately after each test.

Official riders must present for a gear check to an accredited Steward after each test and it is optional to have one before the test.

Riders cannot dismount or leave the main ring after a gear check, if you do you will be required to present for another gear check.

All helmets are required to be tagged with a current visible EA 'Helmet Tag'.

Riders must be aware of the EA rules banning clipping/shaving or modifying sensory hairs (whiskers) or removing or shortening the hair within the rims of the auricle (ears). Non-compliance will result in elimination.

#### **Grounds and Conditions**

Etiquette for the competition & warm-up arenas shall be observed at all times as per Section 3 of the [EA Dressage Rules](#).

Warm-up will be allowed in one back arena or if notified in the main rodeo ring prior to gear check.

Lunging is allowed in the bull ring at 15 min intervals or out the back of Kerribee Park away from the yards and competition area.

Lunging is not allowed on the warm-up/competition arenas on the day of the competition or the day before the competition.

Horses can be ridden (but not on the lunge) in the bull ring for the same period of time i.e. 15 min, if required.

## **Camping**

All participants must comply with [Kerribee Park rules](#) and conditions see:

No temporary yards/fences made of electrical fencing/rope or similar material are to be erected anywhere on the grounds.

## **Dogs**

Dogs are not allowed in or adjacent to the competition and warm-up arena, including in front of the yards.

For those camping with a dog/s, you must camp to the north or east of the toilet block located opposite the care takers residence.

Dogs are permitted but must be always on a chain or lead and under the strict control of the owner.

Dogs must not be allowed to bark excessively Refer to <https://msc.qld.gov.au/council/animal-management/dogs/barking-dogs/>

All dog droppings and horse manure must be disposed of by owners.

No smoking or consumption of alcoholic beverages to take place in the competition, warm-up or presentation areas.

Riders must be familiar with the ATDDEA Risk Management Plan. Go to our website

ATDDEA recommends that horse vaccinations for Strangles, Tetanus and Hendra are up to date.
